WHEREAS, the establishment of Local Public Health Services Collaborative, LLC. (LPHSC) electronic medical record system requires complying with their existing fees for immunizations when using their billing system (non-VaxCare provided vaccines);

WHEREAS, the fees are evaluated and updated annually by LPHSC and the Logan County Health District will follow their fee schedule changes in the future;

WHEREAS, in the event a client chooses to self-pay (and does not qualify for Ohio Department of Health 317 vaccines), the 75% fee would be implemented for time of service payment;
